JHD Postgraduate Fellowship

The Justice, Health, and Democracy Impact Initiative seeks to fill a two-year post-graduate fellowship in the area of democracy and political economy. We seek a scholar or practitioner with a strong commitment to justice, ethics, and American democracy to lead policy research and dissemination under the Initiative's Democracy work stream with an emphasis on the role of economic dignity and security in supporting a healthy democracy.

We seek a scholar or practitioner with a strong commitment to justice, ethics and American democracy to lead policy research and dissemination under the Initiative's Democracy workstream with an emphasis on the role of economic dignity and security in supporting a healthy democracy. Areas for research and dissemination include developing a framework connecting economic dignity and security with democratic values; evaluating existing frameworks, such as Community Wealth Building, for community-level strategies and policies; and policy interventions to promote local entrepreneurship and the growth of small and medium-sized enterprises, especially with reference to diversity, equity, and inclusion.

Fellows-in-Residence Program

We are now accepting applications for our Fellows-in-Residence program.

For the 2022-23 academic year, our theme of "A New Social Compact?" will continue. Variations in national responses to the pandemic; disparate experiments with technology, economic, and health policies; and conflicts over foundational political institutions have thrown into stark relief different conceptions of the social compact (a phrase we use loosely to refer to shared understandings of what members of societies believe they owe to each other) around the world. Myriad challenges—including challenges relating to education, climate and the natural environment, migration, new technologies, public health, elections, racial justice, and economic well-being—call us to revisit and evaluate existing conceptions of the social compact at both national and global levels. We ask, is it time for a new social compact?

We invite applications from a broad range of researchers and practitioners who will work over the course of the year on pressing issues in ethics. Faculty in arts and sciences and professional schools, postdoctoral scholars, practitioners, and researchers from industry, government, and NGOs are eligible to apply.

All eligible applicants are encouraged to apply. Priority will be given to early career scholars and practitioners.
